NOTICE OF PUBLIC HEARING

**SARAH DRIVE ROAD IMPROVEMENTS
SPECIAL ASSESSMENT DISTRICT NO. 1**

NOTICE IS HEREBY GIVEN that the Township Board of the Township of Putnam, Livingston County, Michigan, has determined to undertake certain public improvements consisting of paving portions of Sarah Drive, within the Township, from the intersection of Dexter Pinckney Road east, for approximately 2,700 feet, to the intersection with Nita Drive and Louise St. ("the Improvements"), located within a special assessment district tentatively designated as the Sarah Drive Road Improvements Special Assessment District No. 1 (the "District"), pursuant to Act 188 of the Public Acts of Michigan of 1954, as amended.

DESCRIPTION OF PROPOSED SPECIAL ASSESSMENT DISTRICT

The Township Board has tentatively determined that all or part of the cost of said Improvements shall be specially assessed against each of the following described lots and parcels, which parcels are benefited by the Improvements and which together comprise the following proposed special assessment district:
